**Nevada Governor-Elect Steve Sisolak to hold press conference  
to encourage uninsured Nevadans to enroll with Nevada Health Link**  
***The deadline for Open Enrollment is Saturday, December 15***

**WHAT:** Leadership from [Nevada Health Link](http://Nevada Health Link), the state's health insurance marketplace, and Nevada Governor-elect Steve Sisolak will deliver an important message to uninsured Nevadans: explore your options for a Qualified Health Plan before the Dec. 15 midnight deadline, because no one can afford to be without health insurance, regardless of health, age or life circumstance.

Governor-elect Sisolak will join Heather Korbolic, executive director of Silver State Health Insurance Exchange, which operates Nevada Health Link, to provide brief remarks including helpful information for consumers to help them enroll in health insurance for 2019 prior to the Dec. 15 deadline. Korbolic will also address obstacles the Exchange has worked tirelessly to overcome, including this year's removal of the Individual Mandate and competing health plans that do not always conform to the regulations set forth in the Affordable Care Act (ACA) nor meet minimum standards of quality.
